

DESCRIPTION

Maryland Behavioral Health Integration in Pediatric Primary Care ECHO aims to connect BHIPP consultants with community pediatric primary care providers and nursing staff to provide didactic presentations and case-based learning through online sessions. The goal of BHIPP ECHO sessions is to improve providers' knowledge of and comfort with mental health screening, evaluation, and in office interventions, with an emphasis on both nonpharmacological and pharmacological treatments.

WHO SHOULD ATTEND

This activity is intended for physicians, nurse practitioners, nurses and physician assistants who work in primary care in young children.

OBJECTIVES

After attending this activity, the learner will demonstrate the ability to:

- Describe the diagnostic criteria for 3 pediatric mental health disorders that can present in primary care.
- Incorporate 3 evidence-based tools and strategies to screening and diagnosis of behavioral health disorders in the pediatric primary care setting.
- Describe 3 evidence based psychosocial interventions that are recommended for treating pediatric mental health problems.
- Describe 3 psychopharmacological treatments for pediatric mental health problems.
